This tuition assistance effort is an individualized covenant between families and Mercy High School as we respect the unique needs, circumstances, and incomes of each family.

As a result of parental input, we are processing family financial information online for convenience and accuracy. The school has implemented the FACTS Grant & Aid Assessment, which is recognized as the most secure and most utilized assessment throughout secondary schools.

The information we gather through FACTS is a helpful tool to guide discussion. As President, I will have a personal conversation with each family before tuition is set, and the completed FACTS Assessment is required for this negotiated tuition agreement.

To help you complete the assessment, we have attached an outline of the information you need in order to be considered for Negotiated Tuition. Below are tips for processing that form:

- Read all the instructions prior to completing the application.
- Keep your login and password information securely saved.
- Under the *School* section, please indicate that Mercy High School is to receive the report.
- **The FACTS Grant & Aid Assessment opened on December 1 (of the current year) and all freshman applications are due February 15 (of the current year). Current students' applications are due March 15 (of the current year).**

You only have to complete the assessment once if you are using it for other schools. The information will also be shared with the Omaha Archdiocese Educational Foundation (OAEF).

Freshmen families and new families will still meet with me privately to develop individualized tuition agreements. I greatly enjoy these conversations and the time spent getting to know each other and your family's needs. Returning families can request their tuition agreements mailed to them after I have reviewed this year's information. Returning families can also request an individual meeting with me.
